Based in Chavannes-sur-Reyssouze (Ain), Bouvard specializes in road freight transport, storage, and logistics activities.

The company which was founded in 1989 by Alain Bouvard, is currently run by his children Nelly and Nicolas along with his nephew Arnaud.

This family business, which benefits from a recognized expertise in road freight transport, has a turnover of more than €3 million and a staff of 25 people.

Thanks to this merger, the Vosges-based MGE group which specializes in the transport and logistics of bulk products with a strong presence in Lorraine, Alsace and Picardy, is continuing its geographical development in Auvergne-Rhône-Alpes, and is targeting a consolidated turnover of more than €100 million.

This transaction also reflects the desire of Bouvard's shareholders, who will remain in charge of the company, to team-up with a partner enabling them to accelerate company's growth.
