Elsan, a leading French private hospital operator, sold its clinic (medical, surgical and obstetrics) in Clermont-Ferrand to Holding 4P, founded by Dr Nicolas Davin, Dr Xavier Llompарт, Dr Wilfried Roquet and Dr Maxime Picard.

The disposal of Clinique de La Plaine took place in accordance with the undertakings made to the French antitrust authority (Autorité de la Concurrence) by Elsan during the completion of the acquisition of Médipôle Partenaires in June 2017.

With 68 beds and places, the clinic and its real estate are being acquired by a consortium of four surgeons external to the clinic, who will move their surgical activities to the clinic after the transaction.
