The acquisition of Le Nettoyage & Peinture Net will increase EMN's revenue to almost €25 million, extend its geographical coverage in the Paris region and strengthen its position among service-sector clients in Paris.

Le Nettoyage & Peinture Net is a leading provider of cleaning and painting services to highend clients in Paris, serving real-estate management companies, other service-sector companies, government buildings and the head offices of large corporations. With over 350 employees, Le Nettoyage & Peinture Net aims to work with clients for which cleanliness is strategically important, in terms of both their image and the working environment of their staff.

EMN was founded in the 1950s in the Manche region of France by the parents of current CEO Johann Moulin. It specialises in cleaning offices, buldings and common aeras of building. Until now, EMN's business has been focused on Normandy (Manche and Calvados regions) and part of Brittany (Ile et Vilaine and Finistère). With the acquisition of Le Nettoyage & Peinture Net, EMN is stepping up its growth and boosting its presence in Paris. Johann Moulin has twice attracted equity investment from Audacia, as well as from its banking partners CIC, Crédit Agricole and BPO (BPCE group), to finance its acquisitions.

"This acquisition will enable us to grow more quickly in the Paris region, taking advantage of Le Nettoyage & Peinture Net's solid business base, premium position and high-quality staff," stated Johann Moulin.

"The two companies have very similar business cultures, focusing on customer satisfaction and developing close ties with clients, which is the best possible guarantee that the deal will be a success," added Jean-François Guiomard, CEO and shareholder, Le Nettoyage & Peinture Net.
